
- Vietnamese version of the report on the study "Forms of Engagement Between State Agencies and Civil Society" has not been published yet;

VUFO-NGO Resource Centre Update CURRENT ISSUES

- The main role of the Resource Centre "Core" functions versus advocacy & policy dialogue;
- Available resources and HR management:
 - Permanent staff versus volunteers;
 - Local staff versus international staff;
 - Inadequate salary scale;
 - Long-term planning & capacity building;
 - Inadequate or non-existent basic equipment: server, computers, printer, bandwidth, software.

VUFO-NGO Resource Centre Update SUGGESTED IMMEDIATE ACTIONS

- Strengthen the "core" functions of the Resource Centre to provide quick and professional services: accurate and up-to-date information; easy online access to relevant documents; regular updates (minutes, reports); encourage exchange of information between partners; focus on facilitation of Working Groups and promote collaboration;
- Redefine Activity Plan for the current year and secure adequate funding for 2009 in close consultations with the Steering Committee (identify sustainable funding sources and increase membership fee).

VUFO-NGO Resource Centre Update SUGGESTED LONG-TERM ACTIONS

- Secure adequate working environment; build the capacity of local staff; work on sustainability plan;
- Redefine the role of the Resource Centre in close consultations with partners and Steering Committee;
- Explore new areas for work in terms of advocacy, policy dialogue and collaboration with other relevant partners in Vietnam;
- Identify potential new INGO members in close consultation with PACCOM and work on public image of the Resource Centre.
